Ideas, Collaborators, and New Connections Combine to Make NAPCRG 2006 a Success

In his opening plenary, **Paul Little, MD, MBBS**, reminded us that ideas, passion, and perseverance are all necessary in the journey of a clinical researcher but not nearly enough if in the absence of having trusted, nurturing colleagues internally and externally along the way. As it has for years, NAPCRG and its 2006 Annual Meeting provided the forum for bringing various researcher communities together for this nurturing.

Tucson provided a wonderful setting and our 629 conference attendants provided the ideas and enthusiasm—all the right ingredients for another successful NAPCRG annual meeting. This year's conference, held October 15–18, 2006, brought together many familiar and new colleagues from around the globe for an outstanding set of concurrent sessions, workshops, forums, and posters that fueled our imagination and invigorated our work.

Three plenary presentations were delivered: **Paul Little, MD, MBBS**, Southampton University, brought us along on his journey as a clinical researcher; **Todd Weber, MD, FACP, FIDSA**, Centers for Disease Control, described the development and proliferation of antimicrobial resistance and their links to appropriate and inappropriate antibiotic use; and **Diane Watson, PhD, MBA**, University of British Columbia, updated us about the Canadian public, provider, and policy perspectives on priorities for information about primary care.

The conference has also become a key meeting place for NAPCRG committees and several affiliate groups to convene and do business. This year, more than a dozen different groups conducted business meetings in Tucson around the annual meeting, showcasing the important role that NAPCRG plays

in creating opportunities for connecting individuals around primary care research. We also know there were many more informal meetings of NAPCRG members who used NAPCRG as a way to connect. In addition, the NAPCRG Board of Directors and the Committees on Advancing the Science of Family Medicine, Communications, Membership, Nominations, and Program also met and reaffirmed their commitment to another year of work on behalf of our membership. A highlight of the meeting was the presentation by **Ann-Louise Kinmonth, MD, FMedSci**, recipient of the 2006 Wood Award for Lifetime Contribution to Primary Care Research, who delighted us with her wit, humor, and profound insights. Also honored at the meeting with President Awards were **Kurt Stange, MD, PhD**, representing the *Annals*

of Family Medicine editorial office, **Joetta Melton**, representing the *Annals* publishing office. Both of these leaders have led outstanding teams that have, in just 5 years, moved the *Annals* from a start-up journal to an indexed and widely respected journal. Also recognized was **Jeannie Haggerty, PhD**, for her many years of service on the NAPCRG program committee.

New this year is our online conference evaluation survey accessible through the NAPCRG Web site www.napcr.org/index.html. Please take a few minutes to let us know what you thought of this year's meeting and what we can do to make next year's even better.

The Program Committee is already at work planning next year's annual meeting to take place October 20–23, 2007 in Vancouver, British Columbia. Mark your calendars and start thinking about submitting your proposals. The 2007 call for proposals will be available in early February.

Fostering Innovation Within NAPCRG

NAPCRG has been extremely successful over recent years, growing in our membership, the quality of the research being presented at our annual meeting, our international reputation, and our level of activity throughout the year in support of primary care research. For NAPCRG to continue to grow and increase our value to our members, it is vital to preserve and expand the spirit of innovation that has been a central value throughout our history. The Board of Directors wants to continue to facilitate and foster innovation throughout NAPCRG and will be dealing with innovation actively in each of our upcoming Board meetings.

One of the key places where innovation can occur is in our Special Interest Groups, or SIGs. The SIGs are a place for people with common research interests, shared methodologies, or shared roles to come together for discussion and potential collaboration. A list of the current NAPCRG SIGs and their chairs can be found on the NAPCRG Web site at www.napcrg.org/special.html. Various groups have generated some important activities for NAPCRG through the years. The publication of "Responsible Research With Communities: Participatory Research in Primary Care," which grew out of a workshop on "Respectful Research With Communities" presented at the 1996 NAPCRG Annual Meeting, is a great example of an important and innovative product of a group of people with shared interests who came together at NAPCRG. Many collaborative research projects have grown out of the SIGs and other, less formal, groups of NAPCRG members who have come together at our meetings. As NAPCRG grows, the SIGs take on even greater importance as smaller gathering places in the midst of the much larger and ever-expanding meeting. NAPCRG

would like to increasingly encourage the activities of the SIGs, including the formation of new SIGs. We will be looking for ways for the SIGs to have an increased presence in our annual meeting, but we also would like to support the SIGs' efforts to be more active between meetings. To further foster SIG activities, the Board voted at its recent meeting to set aside \$10,000 for the 2006–2007 fiscal year for innovative projects by the SIGs or by other groups of NAPCRG members with shared interests. Beginning February 2007, any group with an innovative idea can request up to \$2,000. The groups should provide a summary of the idea or activity (up to two pages), along with a brief budget, and send it to Stacy Brungardt, CAE, napcrg@stfm.org for presentation to the Executive Committee of the Board (consisting of the president, president-elect or immediate past-president, the secretary-treasurer, and the executive director). The Executive Committee has been empowered by the Board to make a quick decision and turnaround, so that the group should have an answer regarding its proposal within a few weeks. By February 2007, we'll post on the NAPCRG Web site the criteria by which the Executive Committee will make its decision regarding funding.

The Board will also be investigating several new ways to provide research training and other support to our members between meetings, supplementing the activities already in place. Members with ideas for NAPCRG are encouraged to share them with us. NAPCRG has always been a hotbed of fresh ideas and energy, and we want to do all we can to continue that innovative spirit.

Striving for Greater Transparency: The NAPCRG Election Process

As NAPCRG has grown, we have outgrown some of our informal structures. One of the structures we have clearly outgrown is our “election”. According to our by-laws, two positions come to the membership for approval—the president-elect and the secretary-treasurer; however we have no formal voting structure. Other members of the Board are appointed. When NAPCRG was an organization of a few hundred, conversations could take place at a business meeting. Now to bring a slate of one and ask for nominations from the floor in a meeting of 600 without any preparation feels uncomfortable at best and fallacious at worst. The NAPCRG Board plans to review our bylaws to bring revisions to our election process to the membership.

In spite of needed change, I do feel comfortable with our leadership and the process that has selected those individuals for NAPCRG leadership roles. Unfortunately, much of the process is not clear to the membership. Let me outline the process that led to our recommendation of **Allen Dietrich, MD**, as president-elect. In the spring of 2005, the members of the Nominations Committee, the Board members, and others approached individual members for their suggestions of NAPCRG members to consider for leadership positions. We also called for general member input in our newsletter.

The characteristics the Nominations Committee looks for in a president-elect include but are not limited to leadership skills, credibility as a researcher, critical thinking skills, ability to work with a board and other leaders within the family, and an understanding of NAPCRG. We also consider the bi-nationality of our membership. Following careful deliberations, the Nominations Committee recommended to the NAPCRG

Executive Committee a ranked list of three candidates. More discussions followed, which resulted in a request to the candidate of choice to be the nominee. The candidate was approved by the NAPCRG Executive Committee, and the individual was then presented to the membership at the Annual Business Meeting.

There has been considerable debate at the Board about a traditional electoral process for our leadership. The Board is trying to balance the need for greater openness of the process versus the need to ensure the best leader is identified for the organization at a given point in time. Changes to our Board composition and election are issues to be considered judiciously and with extensive member input. More to come.

Welcome Our New President-Elect: Allen Dietrich, MD

Election revisions aside, I am extremely pleased with quality and character of our incoming president-elect. Let me share a bit more about why the Board is so pleased that Dr Dietrich accepted the challenge to lead NAPCRG.



Dr Dietrich is a family physician and professor of community and family medicine at Dartmouth Medical School. He has extensive research experience having been principal investigator on a number of National Cancer Institute-sponsored projects with settings ranging from rural New England to New York City, Boston, and remote Alaskan villages. He has devoted his academic career to developing resources and strategies to help primary care clinicians provide high quality, efficient care. His honors include membership in the Institute of Medicine of the US National Academy of Sciences, the Society of Teachers of Family Medicine (STFM) Curtis Hames Award for career research achievement, and recognition for STFM Best Research Paper Awards in 1989, 2001, and 2006.

After receiving his undergraduate degree from Swarthmore College, he completed his MD degree at Case Western Reserve University. After completing an internship at Cambridge Hospital in Massachusetts and a family practice residency at the University of Rochester, he served as clinical director at the Zuni Indian Health Service Hospital in New Mexico, and then completed a Robert Wood Johnson Clinical Scholars Program at Stanford University and The Palo Alto Veterans Administration Hospital.

Dr Dietrich joined the Dartmouth faculty in 1982 where he has provided continuity of care to patients of all ages while pursuing research in cancer screening and prevention, office systems, and depression management.

We welcome Dr Dietrich to the NAPCRG Board and look forward to his vision and leadership in the coming years.

More specifically, we want to:

1. Establish NAPCRG as a vibrant and reputable organization among health care reporters at key medical trade and national print news outlets.
2. Enhance awareness about the value of primary care research among those in the research community, especially decision makers in policy-making positions.
3. Position NAPCRG's annual meeting as the premier meeting for the dissemination of the best in primary care research, and generate media coverage of the research presented at the meeting.

We will be reporting our plans and actions in upcoming newsletters and at the annual meetings.

NIH Funding for Primary Care Researchers for Testing Point-of-Care Technologies

The National Institute of Biomedical Imaging and Bioengineering invites applications for Research Centers in the area of point-of-care (POC) technologies. POC testing refers to the timely provision of clinical diagnostic information, often in decentralized settings such as in the physician's office or in the patient's home.

The NIBIB anticipates commitment of up to \$6,000,000 in FY2007 for this program for up to three awards. The U54 (cooperative agreement) mechanism will be used to create a national research network that works to build expertise in the development of integrated systems that address unmet clinical needs in POC testing through the creation of multidisciplinary partnerships. Each POCT Center will perform five core functions (as described below) to create a dynamic structure that facilitates the translation of emerg-

ing technologies into clinical application. The centers will work jointly to create a Research Network with broad expertise in the development of POC technologies.

Each center within the network will perform or facilitate five different core functions: (1) conducting in-house clinical testing of prototype POC devices; (2) collaborating with physical scientists, biochemical scientists, computational scientists, and engineers on exploratory technology development projects; (3) completing clinical needs assessments in areas anticipated to advance the field of POC testing and disseminating this information to the technology development community; (4) providing training to technology developers on clinical issues related to the development of POC devices; and (5) providing an adequate administrative structure to ensure that the large, complex Center achieves its goals.

NAPCRG Members Honored With CFPC Research Awards

At our recent Family Medicine Forum (FMF) held in Quebec City (November 1–4), we were pleased to honor the recipients of our 2006 research awards at the College of Family Physicians of Canada Section of Researchers (SoR) annual general meeting, and at our SoR dinner. The CFPC research award recipients for 2006 are:

Family Medicine Researcher of the Year—William Hogg, MD, University of Ottawa

Dr Hogg's research involvement has already spanned 3 decades and is still gaining momentum. His early work began in a small rural practice in Wakefield, Quebec. Early published work involved studies on rural obstetrics, computerization, prevention, and the philosophy of family medicine. These studies informed his later body of work investigating facilitation in family practices, the role of home hospitals, and in integration of the family health team. Dr Hogg has had a long-lasting interest in prevention, and systems within the modern family practice, and has become internationally recognized as a researcher in the field of prevention in primary care and in the area of the utilization of facilitators in practice to enhance the quality of care delivered. He has been a wonderful mentor to other faculty members, both new and old, with his primary motivation being to enhance family medicine research, rather than to enhance his own career. His current work forms an evolving body of knowledge that has, and will continue to, inform the process of primary

care reform in Canada. In the midst of this, he continues with a desire to investigate clinical issues, and in recent times, even the challenge of SARS.

- Approved the elimination of two seats on the NAPCRG Board of Directors, effective October 2006: the Community Hospital Representative and the Academic Family Medicine Organizations Research Representative.

Participate in NAPCRG's Student Research Award Program

To encourage departments of family medicine to recognize primary care research performed by students, NAPCRG offers a research award for students called the NAPCRG Student Family Medicine/Primary Care Research Award. This award is intended to recognize outstanding family medicine/primary care research performed by a medical student.

One award may be made by each department of family medicine. NAPCRG suggests that each department create a committee to review medical student applications and make the award recommendation to the department chair. Note that NAPCRG does not select the honorees; departments tell NAPCRG headquarters who should be honored from their school. NAPCRG will supply the certificate that may be framed by the department, if it elects to do so.

Please submit the name of your honoree to Kelly Parry at kparry@stfm.org for preparation of the certificate. While some departments prefer to present these certificates at graduation ceremonies in the spring, you may honor your student at the time that makes the most sense for your department.

Watch for the NAPCRG Methodological Consultants Directory

Based on the 2005 Members Survey, there is a need for access to consultation and collaboration among members. Fortunately, 56% of survey respondents indicated a willingness to serve as a research consultant to NAPCRG members. In response, the Board of Directors has approved the establishment of an online Consultants Directory.

Of the 85 methodological topics, only four (virtual reality, agent-based modeling, canonical correlation, and critical theory) had no consultant identified. The 59 consultants reported a mean of 16.4 (\pm 8.0) years of research experience while 60% consider themselves experienced researchers and 52% have received major research funding.

Soon the directory will be accessible through the NAPCRG Web site at www.napcr.org. By logging in to the directory, you will be presented with lists of quantitative and qualitative methods, technologies, and development and design issues. Simply click on the topic for which you seek consultation and then indicate what level of consultation you desire. The five levels listed will be 1) **resource** (a brief consultation to answer questions or provide resources), 2) **teaching** (an extended consultation in which the consultant will instruct the member in the topic), 3) **review of manuscripts or grant proposals** (expert critique

focused on the topical area and the consultant's expertise), 4) **grant consultant** (providing assistance in grant preparation in exchange for inclusion on the proposal as a consultant), and 5) **coinvestigator** (providing assistance in grant preparation in exchange for inclusion on the grant proposal as coinvestigator). The availability of consultation depends upon the topic and the level of consultation. Once you have selected the level of consultation you need, a list of available consultants will appear along with contact information.

While service as grant consultant or coinvestigator involves an investment of time, it also holds the possibility of monetary and academic compensation through grant funding and publication. Service as a teacher or reviewer, on the other hand, involves significant time investment without obvious compensation. Therefore, suggested fees for teaching and review will be indicated, but it will be up to the consultant and the member to negotiate any compensation.

The Membership Committee is seeking additional ways to facilitate members' ability to easily find collaborators and receive consultation when needed. Stay tuned for more information about this online consultation service.

Dr Nordstrom will collaborate with faculty in Ukraine to design and teach new courses in public health, epidemiology, and research at a new university graduate study program in the nation's capital. Dr Nordstrom is one of approximately 800 US faculty and professionals who will travel abroad to some 150 countries during 2006–2007 through the Fulbright Scholar Program. Established in 1946, the program's purpose is to build mutual understanding between the people of the United States and other countries.

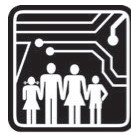
Post Your Annual Meeting Handouts on FMDRL
